## **PUBLIC NOTICE FOR APPROVAL PROCESS 2025-26**

The All India Council for Technical Education (AICTE) invites applications from Education Partners (Stakeholders) for the following proposals:

1. **Setting up New Technical Institutions** in the following programs at all the levels (Diploma, Post Diploma, Under Graduate, Post Graduate, Post Graduate Diploma in Management, Post Graduate Certificate in Management and FPM (in Management)) etc: (including BBA/BCA/BMS)
  - o Engineering and Technology
  - o Planning
  - o Applied Arts and Crafts
  - o Design
  - o Hotel Management and Catering Technology
  - o Computer Applications
  - o Management
2. **Extension of Approval for Existing Technical Institutions,** Institutions Deemed to be Universities, or Universities (Central/State/Private).
3. **Approval/NOC for Open and Distance Learning (ODL) or Online Mode Programs** in the following fields for Standalone Institutions or Institutions Deemed to be Universities at Certificate / Diploma / Degree:
  - o Management – Business Administration, Logistics and Travel & Tourism
  - o Computer Applications – Computer Application, Artificial Intelligence and Data Science, Artificial Intelligence and Machine Learning, Cyber Security and Block Chain

All applicants are strongly advised to thoroughly read the AICTE Approval Process Handbook (APIH) 2024-25 to 2026-27, along with any amendments issued from time to time, available at [www.aicte-india.org](http://www.aicte-india.org). Applications for the Academic Session 2025-26 must be submitted online via the AICTE Web Portal.

### **Submission Guidelines:**

- Education Partners seeking to establish new Technical Institutions must submit their applications through the "National Single Window System (NSWS)" available at <https://www.nsws.gov.in>, adhering to the provisions of the APIH 2024-25 to 2026-27.
- Central, State, or Private Universities seeking AICTE approval for their Technical Programs must apply for all programs. Partial approval will not be permitted. If partial approval is obtained, it will be subsequently withdrawn.
- For Institutions Deemed to be Universities, AICTE approval has been mandatory since the Academic Year 2018-19, in compliance with the Supreme Court order dated November 3, 2017 (CA No. 17869-17870/2017).
- Standalone Institutions, Institutions Deemed to be Universities offering or intending to offer ODL or online programs must submit applications as per the provisions laid out in the APIH.

### **Important Notes:**

- Institutions Deemed to be Universities recognized as Institutes of Eminence by the Ministry of Education, Government of India, must annually update their details on the AICTE Web Portal and comply with AICTE norms and standards.
