महोदय,

महाराष्ट्र शासनाने उपरोक्त संदर्भ क्र. १ नुसार विद्यापीठ व महाविद्यालयीन शिक्षकांना सातवा वेतन आयोग लागू केला आहे. सदर शासन निर्णयाची अंमलबजावणी करण्यासाठी मा. कुलगुरू महोदयांनी संदर्भ क्र. २ अन्वये निदेश क्र. ४/२०१९ दि. २५ मार्च, २०१९ रोजी निर्गमित केलेला असून या निदेशान्वये विद्यापीठ व महाविद्यालयीन शिक्षकांना सातवा वेतन आयोग लागू करून संदर्भिय क्र. १ च्या शासन निर्णयातील कलम १.० नुसार विद्यापीठाने वेतन निश्चिती करावयाची आहे. या संदर्भात मा. अवर सचिव, उच्च व तंत्र शिक्षण विभाग, महाराष्ट्र शासन, मंत्रालय, मुंबई, मा. संचालक (उ.शि.) महाराष्ट्र राज्य, पुणे व सर्व विभागीय मा. सहसंचालक व उच्च शिक्षण विभागाच्या इतर अधिकाऱ्यांसमवेत सावित्रीबाई फुले पुणे विद्यापीठ, पुणे येथे दि. ८.४.२०१९ रोजी झालेल्या बैठकीत चर्चा करण्यात आली.

त्याअनुषंगाने वेतन निश्चितीची प्रक्रिया सुलभ व पारदर्शक होण्याकरिता विद्यापीठाने समिती गठित केली आहे. सदर समितीकडून विद्यापीठ व महाविद्यालयीन शिक्षकांची वेतन निश्चितीची प्रक्रिया राबविण्यात येणार आहे. समितीचे कामकाज जलद गतीने व सुलभ व्हावे म्हणून संलग्नित महाविद्यालयांना खालीलप्रमाणे मार्गदर्शक सूचना देण्यात येत आहेत :

१. महाविद्यालयीन शिक्षकांची सातव्या वेतन आयोगाप्रमाणे विद्यापीठस्तरा वरून वेतन निश्चिती करण्यासाठी वेळापत्रक सोबत जोडल्या प्रमाणे राहिल.

२. संबंधित महाविद्यालयाच्या मान्यताप्राप्त प्राचार्यांनी जाणकार कर्मचाऱ्यांसह वेळापत्रकानुसार विद्यापीठाच्या दृकश्राव्य कक्षात महाविद्यालयाच्या खर्चाने उपस्थित राहून वेतन निश्चिती करून घ्यावयाची आहे.
३. महाविद्यालयाच्या आस्थापनेवरील शासनमान्य पदावर पूर्ण वेळ कार्यरत असेलेल्या शिक्षकांचीच वेतन निश्चित केली जाईल.
४. शिक्षकांच्या सेवापुस्तिकेमधील नोंदी अद्ययावत, पूर्ण व अचूक असणे आवश्यक आहे.
५. संदर्भीय शासन निर्णय व निदेश क्र. ४/२०१९ नुसार सर्व शिक्षकांची वेतन निश्चिती प्रथमतः आपल्या स्तरावरून करून घ्यावयाची आहे. शासन निर्णयासोबत जोडलेल्या Accompaniment to Government Resolution, Higher and Technical Education Department No. Resolution No. Misc-2018/C.R.56/18/UNI-1, dated 08 March, 2019.
