# DIRECTION NO.06/2023

Sub. :"Direction relating to the nomination of Acting Dean for faculty of Humanities of Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon."

WHEREAS, in exercise of the powers conferred by Sub section 2 of Section 1 of the Maharashtra Public Universities Act, 2016 (hereinafter referred to as "said Act"); Government of Maharashtra has published said Act in the Maharashtra Government Gazette on 11th January, 2017 which came into force on 1st March, 2017 by repealing the Maharashtra Universities Act, 1994;

WHEREAS, the "said Act" provides, Dean for each faculty under Section 15 (1) who shall be a full time salaried officer;

### And

WHEREAS, as per sub section 2 of Section 15 of the "said Act", the Dean of each faculty shall be appointed by the Vice-Chancellor on the recommendations of the Selection Committee constituted for that purpose;

WHEREAS, as per sub section 1 of Section 34 of the "said Act", Faculty shall be the Principal Academic Coordinating Authority of the University in respect of studies and research in relation to the subjects included in the respective faculty;

### And

WHEREAS, the Dean of each faculty shall be responsible for academic planning and academic audit of the programmes and implementation of academic policies approved by the Academic Council in respect of academic development, maintenance of quality of education including standards of teaching and research and training of teachers within his faculty, who is also responsible for development of quality culture in higher education.

## And

WHEREAS, as per sub section 2 of Section 34 of the "said Act" the University shall have following four faculties namely:

Faculty of Science and Technology

(ii) Faculty of Commerce and Management

Faculty of Humanities and (iii)

(iv) Faculty of Inter-disciplinary Studies

#### And

WHEREAS, Deans are yet to be appointed by the Vice-Chancellor in accordance with the provision of the "said Act".

# And

WHEREAS, to regulate and workout, the above analogous and the emergent situation;

It is necessary to take immediate action to nominate the Acting Dean of the faculty of Humanities and taking into consideration the provision as well as powers conferred upon me under the provisions of sub section 1,4,5,7,8 and 10 of the Section 12 of the "said Act", for implementation of academic policies of this university and keeping in view the larger interest of the students as well as maintaining standard of teaching and research and to formulate the policies and development programmes and day to day academic functions of this University; and also to constitute the authorities/bodies of the University before stipulated time frame;

I, Prof.Vijay Laxminarayan Maheshwari, Vice-Chancellor, Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon as per the powers conferred upon me under the provisions of sub section 8 of the Section 12 of the "said Act", issue Direction and nominate "Acting Dean" as under who is otherwise an "Academic Officer" for faculty of Humanities of this university with responsibility to implement the academic policies as per the "said Act", who will hold the post until regular "Dean" for concern faculty is appointed as per sub section 2 of Section 15 of the "said Act" or upto 31.12.2024 or till he/she attains the age of superannuation, whichever is earlier.
