Subject: Regarding initiative for supporting noble cause of eye donation by the University in the upcoming year 2024-25.

On the occasion of 74th Birthday of Hon'ble Prime Minister of India on 17.09.2024, the Governor's Secretariat, in collaboration with Sir. J.J. Group of Hospitals, Mumbai organized an "Eye Donation Fortnightly Campaign" from 4th to 17th September 2024 at Raj Bhavan, Mumbai.
