

प्रस्तावना :

उच्च व तंत्र शिक्षण विभाग, शासन निर्णय दिनांक ०२ जून, २०२१ अन्वये, राज्यातील अकृषी विद्यापीठे, तंत्र विद्यापीठ व अधिनस्त महाविद्यालयाच्या विद्यार्थ्यांसाठी नवीन स्वरूपात “विद्यार्थी जीवन / अपघात विमा योजना” लागू करण्यासाठी संचालक, उच्च शिक्षण यांच्या अध्यक्षतेखाली समिती गठीत करण्यात आली होती. सदर समितीच्या अहवालानुसार राज्यातील विद्यापीठीय व महाविद्यालयीन विद्यार्थ्यांसाठी “विद्यार्थी अपघात विमा” योजना नवीन स्वरूपात लागू करण्यासंदर्भात, IRDAI परवानाधारक एक अनुभवी सल्लागार नेमून, त्यांना या विषयाबाबत सखोल अभ्यास करून अंमलबजावणी करण्यासारख्या बाबी तसेच त्यांच्या कार्यपध्दतीबाबत अहवाल सादर करण्याबाबत कळविण्यात आले होते. संचालक उच्च शिक्षण यांनी, निविदा छाननी समितीने तांत्रिक मुल्यमापन करून गुणांकनाच्या आधारे “इन्टिग्रेटेड रिस्क इन्शुरन्स ब्रोकर लिमिटेड” या विमा सल्लागार कंपनीची निवड केली होती.

प्रस्तुत विद्यार्थी अपघात विमा योजना संदर्भात विमा संचालनालय यांचे राज्यातील अकृषी विद्यापीठे व महाविद्यालयीन विद्यार्थ्यांसाठी प्रस्तावित करण्यात आलेली विद्यार्थी अपघात योजना संदर्भात अभिप्राय घेण्यात आले होते.

प्रस्तूत IRDAI परवानाधारक सल्लागार तसेच विमा संचालनालय यांचे सुचनांनुसार अकृषी विद्यापीठे तसेच संलग्नित महाविद्यालये येथे विद्यार्थी वैयक्तिक अपघात विमा (Personal Accident Insurance) तसेच विद्यार्थी वैद्यकीय विमा (Medical Insurance) अंमलात आणण्यासाठी आयआरडीए परवानाधारक विमा कंपनी निवडण्यासाठी ई-निविदेद्वारे निविदा प्रक्रिया राबविण्यात आली. ई-निविदेमधील तरतूदीनुसार न्युनतम निविदा धारकासोबत दराबाबत वाटाघाटी करुन संचालक, उच्च शिक्षण यांनी सादर केलेल्या दि.२७.०९.२०२३ च्या प्रस्तावानुसार विद्यापीठ व महाविद्यालयातील विद्यार्थ्यांसाठी अपघात विमा योजना राबविण्याची बाब शासनाच्या विचाराधीन होती.
