### **MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF DIRECTOR OF PHYSICAL EDUCATION IN COLLEGES, AS PER UGC REGULATIONS**

- i. A Masters degree in Physical Education or Masters degree in Sports Science with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) with a consistently good academic record.
- ii. Record of having represented the university/college at the inter-university/inter-collegiate competitions or the state and/or national championships.
- iii. Qualifying in the National Eligibility Test (NET) or other accredited test like SLET/SET in Physical Education conducted for the purpose by the UGC or any other agency approved by the UGC.
- iv. Passed the physical fitness test conducted in accordance with the Regulations.
- v. However, candidates, who are, or have been awarded Ph.D. Degree in accordance with the "University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree), (Through a process of admission, registration, course work and external evaluation as laid down in the UGC Regulations, 2009) shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of College Director of Physical Education.

- vi. A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/ Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5 % to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.

**General Conditions:-**

1. The Reserved category candidates should submit their cast validity certificates as per the Government Resolution.
2. As per the Government Resolution No BCC-2016/PK228A/16/16B, dated 29 th May, 2017, A/B/C/D/ points in VJ/NT Category are interchangeable.
3. The Reserved category candidates (except SC and ST ) should submit their Non – Creamy Layer Certificate at the time of interview.
4. The original certificates must be produced at the time of interview.
5. For reserved category post, candidates belonging to the concerned reserved category only should apply.
6. Candidates already employed must submit their application through proper channel.
7. Reservation for woman and persons with disabilities, etc will be as per the norms of Government of Maharashtra.

**Note :-** The appointment will be on the basis of final decision of Hon'ble High Court, Aurangabad Bench of Writ Petition No. 12051/2015.
