MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF DIRECTOR OF PHYSICAL EDUCATION in COLLEGES AS PER UGC REGULATIONS

- A Masters degree in Physical Education or Masters degree in Sports Science with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) with a consistently good academic record.
- Record of having represented the university/college at the inter-university/inter-collegiate competitions or the state and/or national championships.
- Qualifying in the National Eligibility Test (NET) or other accredited test like SLET/SET in Physical Education conducted for the purpose by the UGC or any other agency approved by the UGC.
- Passed the physical fitness test conducted in accordance with the Regulations.
- However, candidates, who are, or have been awarded Ph.D. Degree in accordance with the "University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree), (Through a process of admission, registration, course work and external evaluation as laid down in the UGC Regulations, 2009) shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of College Director of Physical Education.
- A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/ Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5 % to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.

General Conditions:-

- The Reserved category candidates should submit their Caste Validity Certificate as per Government Resolution.
- As per the Government Resolution NO. BCC-2016/PK 228A/16/16 B, Dated 29th May, 2017, A/B/C/D points in VJ/NT Category are interchangeable.
- The Reserved category candidates (except SC and ST) should submit their Non-creamy Layer Certificate at the time of interview.
- The original certificates must be produced at the time of interview.
- For reserved category post, candidates belonging to the concerned reserved category only, should apply.
- Candidates already employed must submit their applications through proper channel.
- Reservation for women and persons with disabilities, etc will be as per the norms of Government of Maharashtra
