**MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF
ASSISTANT PROFESSOR IN COLLEGES, AS PER REGULATION**

- Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Mastersdegree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.

- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- iii. However, candidates, who are, or have been awarded Ph.D. Degree in accordance with the “University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) (Through a process of admission, registration, course work and external evaluation as laid down in the UGC Regulations, 2009) shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of college Assistant Professor.
- iv. A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/Differently-abled (physically and visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions, The eligibility marks of 55% marks (or and equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the Qualifying marks without including any grace marks procedures.

General Conditions:-

1. The Reserved category candidates should submit their Caste Validity Certificates as per the Government Resolution.
2. As per the Government Resolution NO. BCC-2016/PK228A/16/16 B, dated 29th May, 2017, A/B/C/D points in VJ/NT Category are interchangeable.
3. The Reserved category candidates (except SC and ST) should submit their Non-creamy Layer certificate at the time of interview.
4. The original certificates must be produced at the time of interview.
5. For reserved category post, candidates belonging to the concerned reserved category only should apply.
6. Candidates already employed must submit their applications through proper channel.
7. Reservation for women and persons with disabilities, etc will be as per the norms of Government of Maharashtra.

Note:- The appointment will be on the basis of final decision of Hon’ble High Court, Aurangabad Bench of Write Petition No.12051/2015.
