A. Eligibility:

- Ph.D. Degree
- Professor / Associate professor with a total service experience of at least fifteen years of teaching/ research in Universities, Colleges and other institutions of higher education.
- A minimum of 10 research publications in peer-reviewed or UGC-listed journals and
- A minimum of 110 Research score as per Appendix II, Table 2

B. Tenure:

A College principal shall be appointed for a period of five years, extendable for another term of five years on the basis of performance assessment by a committee appointed by the university, constituted as per government resolution dated, 8th March, 2019,

General Conditions:

- Service conditions and other rules will be as prescribed by the UGC, State Govt. and KBC North Maharashtra University.
- The original certificates must be produced at the time of interview.
- Candidates already employed must submit their applications through proper channel.

**MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF ASSISTANT PROFESSOR ,
AS PER UGC REGULATION, 2018 and G. R. DATED 8th March, 2019**

A)

- i) A Master's degree with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations. 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET: Provided the candidates registered for the Ph.D. programme prior to July 11,2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent position in Universities /Colleges/ Institutions subject to the fulfilment of the following conditions:
 - a) The Ph.D. degree of the candidate has been awarded in regular mode only.
 - b) The Ph.D. thesis has been evaluated by at least two examiners.
 - c) An open Ph.D. viva voce of the candidate has been conducted.
 - d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal and
 - e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

Note:

- 1) The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

- The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the world University Ranking (at any time) by any one of the following:
- i. Quacquarelli Symonds (QS).
 - ii. the Times Higher Education (THE) or
 - iii. the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).
- A relaxation of 5% shall be provided, (from 55%to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
 - A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.

- A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Loco-motor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

General Conditions:

1. Service conditions and other rules will be as prescribed by the UGC, State Govt. and Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon.
2. The original certificates must be produced at the time of interview.
3. Candidates already employed must submit their applications through proper channel.
4. As per Govt. Resolution No. STC-1099/PK-14/C-10, dated 16th August, 2000 & STC/14200/PK-43/C-10, dated 27th January, 2003 candidates belonging ST Category is mandatory to submit cast validity certificate at the time of interview.
5. The reserved category candidates should submit their Caste Validity Certificates as per the Government Resolution.
6. As per the Government Resolution NO. BCC-2016/PK228A/16/16B, dated 29th May, 2017, A/B/C/D points in VJ/NT Category are interchangeable.
7. The Reserved category candidates (except SC and ST) should submit their Non-creamy Layer Certificate at the time of interview.
8. For reserved category post, candidates belonging to the concerned reserved category only can apply.
9. 30% Reservation for women shall be observed as per Government norms.
10. 4% reservation for persons with disabilities as per G.R. dated 29.05.2019 shall be observed.
