

Note: - Candidates who have done Ph. D after the Bachelor Degree from institution of National importance with GATE/ GPAT CEED shall be eligible for the post of Assistant Professor.


General Conditions: -

2. The original certificates must be produced at the time of interview.
3. Candidates already employed must submit their applications through proper channel
4. As per Govt. Resolution No. STC-1099/PK-14/C-10, dated 16th August, 2000, and STC/14200/PK-43/C-10, dated 27th January, 2003 candidates belonging to ST Category is mandatory to submit caste validity certificate at the time of interview.
