- Record of organizing such events as student's convener or in later part of life.


General Conditions:-

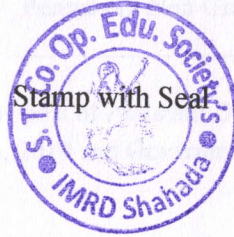

- The original certificates must be produced at the time of interview.
- Candidates already employed must submit their applications through proper channel.
- As per Govt. Resolution No. STC-1099/PK-14/C-10, dated 16 August, 2000 & STC/14200/PK-43/C-10, dated 27th January, 2003 candidates belonging to ST Category is mandatory to submit cast validity certificate at the time of interview.
- The reserved category candidates should submit their Caste Validity Certificates as per the Government Resolution.


