D. Minimum Qualification for Appointment of Librarian in Colleges, as per UGC Regulations,2018 and G.R. dt. 8 March ,2019.

- i) A Master's Degree in Library Science, Information Science or Documentation Science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point- scale wherever the grading system is followed).
- ii) A consistently good academic record, with knowledge of computerization of a library.
- iii) Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SET. or who are or have been awarded Ph. D Degree in accordance with the "University Grants Commission (Minimum Standards and Procedure for Award of M. Phil / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.
