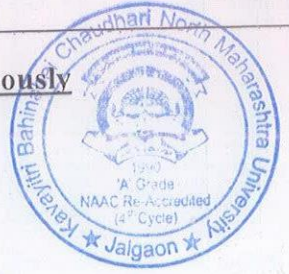

Guidelines for Pursuing Two Academic Programmes Simultaneously
From KBC North Maharashtra University



1. Introduction:

National Education Policy (NEP) 2020, by and large emphasizes flexibility, interdisciplinarity, and holistic education. One such avenue to attain the goals, what has been laid down by the NEP can be augmented through Implementing two Academic Programmes Simultaneously.

Pursuing two academic programs simultaneously can offer several benefits, especially in the context of the National Education Policy (NEP) 2020 in India.

Some of the key reasons why students might choose two academic programs simultaneously

- Holistic Development:** It allows students to develop a well-rounded skill set by combining different disciplines, such as arts and sciences, which can lead to a more comprehensive education.
- Flexibility and Multidisciplinary:** The NEP 2020 emphasizes flexible and multidisciplinary education. By pursuing two programs, students can explore diverse fields and interests, making their education more dynamic and adaptable to various career options.
- Enhanced Career Opportunities:** Having qualifications in multiple areas can make students more competitive in the job market. It can open up a wider range of career opportunities and make them more attractive to employers.
- Efficient Use of Time:** For motivated students, pursuing two programs can be an efficient way to maximize their time and educational investment, especially if one of the programs is offered through distance or online learning

2. Scope

This SOP is applicable to all on-campus and affiliated colleges/institutes students of the university who wish to enroll in two simultaneous degree programs under the offline and distance mode offered by KBCNMU or any UGC-recognized institution.

3. Eligibility for pursuing two simultaneous degree programs

- The student must be a regular student enrolled in an undergraduate (UG) or postgraduate (PG) program.

4. Program Combinations Permissible

In line with the objectives of the National Education Policy (NEP) 2020 and the UGC guidelines on pursuing two-degree programs simultaneously, the university offers students the flexibility to pursue two academic degrees concurrently. To facilitate this, the university permits specific combinations of program modes that ensure academic rigor, feasibility, and compliance with regulatory frameworks. The following combinations have been identified as permissible for enrolment:

Illustrative combinations:

(1) Offline Mode: Regular - Regular (Evening)

- UG-B.Sc. (Primary College/Institute/School) and Other UG-B.Sc. Degree can be in another Subject /B.A./B.Com.
- PG-M.Sc. (Primary College/Institute/School) and Other PG-M.Sc. Degree can be in another Subject /M.A./M.Com.
- PG-M.Sc. (Primary College/Institute/School) and Other UG-B.Sc. Degree can be in another Subject /B.A./B.Com.

(3) Offline and Distance Mode: Regular - Distance (YCMOU Nashik)

- UG or PG Regular Students from KBCNMU can pursue another PG or UG Degree in distance mode from YCMOU Nashik subject to fulfilment of eligibility criterion of particular programme.

5. Admission Process & Document to be Submitted

C) Students who are admitting to the **Regular Programme in any School of KBCMU or Affiliated Colleges of University**, he/she must submit all the original document with Primary Institute/College/School which Includes

4. Original Marksheet
5. Leaving Certificate
6. Other necessary Documents as may be prescribed by KBCNMU

D) For **Admission to Second Degree Programme** the student Compulsorily need to forward his application from parent School or Affiliated Colleges and photocopies of all the documents submitted to the Primary College/Institute/School attested by respective Principal/Director along with NOC from the University must submit with the second College/Institute/School.

Procedure for Obtaining NOC for admission to a Two-degree program:

Students seeking admission to a Two-degree program at Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon, must obtain a No Objection Certificate (NOC) by applying online through the university portal:

Applicants are required to register by providing their personal and academic details pertaining to their current course of study. The following documents must be uploaded during the application process:

- * Recent passport-size photograph
- * Signature
- * Marksheet of the qualifying examination
- * Forwarding letter from the principal of the college currently attended (Click for Format)

After uploading the documents, applicants must pay the prescribed fee Rs. 50/- through online mode. Upon successful submission, the university will verify the submitted documents and issue the NOC to eligible candidates for enrolment in the Two-degree program.

The second institute shall admit only those students who have the university issued NOC. The institution shall also verify eligibility of the students for desire programme.

6. Fees and Financial Guidelines


- The fee for the first/second degree program shall be charged as per the fees structure of the respective College/Institute/School.
- There shall be no financial relaxation for pursuing simultaneous degrees.

7. General Instructions

- After passing the degree program it is responsibility of the Primary Institute/College/School to issue Leaving/Transfer Certificate and the Institute where the student is pursuing second degree program will issue only the Certificate stating the passing status of the student.
- For both the degree programs the Eligibility Procedure shall be followed separately by respective College/Institute/School as per the prescribed rules of the university.
- Students are not eligible to pursue two programmes of the same level in the same subject simultaneously
- Students enrolling for the two academic programmes simultaneously, must declare his / her first degree.
- The candidate shall not take benefits of the credit transfer for a particular course, completed either in online or offline mode, in both the programmes.

- The minimum eligibility conditions for pursuing two academic programmes simultaneously shall be same as that of its regular mode.
- It shall be responsibility of the student who is pursuing two academic programmes simultaneously to maintain minimum attendance of 75%.
- A student can pursue two full time academic programmes in physical mode simultaneously on condition that there is no overlap in the class timings of both the programmes i.e., classes of one programme may be in the morning, while that of the other in the evening.
- Examination schedule(s) of the students who are pursuing two academic programmes should not overlap. In case of overlap, examination schedule of the primary institution shall not be changed under any circumstances.
- The candidate shall be eligible to receive the scholarship and other incidental benefits from the primary institution only and shall have to give a written undertaking at both the institutions stating that he / she will avail such benefits from only one institute i.e. from the primary institute and shall be solely responsible for consequence if he / she avails such benefits from both the institutions simultaneously.
- These guidelines are applicable only to the students pursuing academic programmes other than Ph.D.
