### **Direction No. 02 / 2025**

#### **Direction Governing the Constitution of Ad-hoc Board of Studies and Appointment of Ad-hoc Chairpersons of the Board of Studies**

Whereas, the Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2017) (hereinafter referred to as "said Act") is published in Maharashtra Government Gazette on 11<sup>th</sup> January, 2017;

And,

Whereas, in exercise of the powers vested to the State Government by sub-section 2 of Section 1 of the said act came into force on 1<sup>st</sup> March, 2017 by repealing the Maharashtra Universities Act 1994, (Maharashtra Act No. XXXV of 1994);

And,

Whereas, by virtue of entry No.8 in the column No.(1) of Part-1 of the SCHEDULE of the "said Act"; read with sub-section 1 of Section 3, of the said Act the Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon (hereinafter referred to as "the University") from 1<sup>st</sup> March, 2017 will be governed by the said Act;

And,

Whereas, there shall be a Board of Studies for every subject or group of subjects as per Section 40 of the said Act;

And,

Whereas, Board of Studies for the various subjects under the concerned faculty is required to be constituted in accordance with the provision stated under sub-section (2) of Section 40 of the said Act;

And,

Whereas, the Board of Studies at its first meeting, shall elect one of the members as a Chairperson of the Board of Studies from amongst its members as per sub clause (i) of clause (d) of sub-section (2) of Section 40 of the said Act;

And,

Whereas, at the time of constitution of Board of Studies, for some Board of Studies, less than three valid nomination were received for election under clause (c) of sub-section (2) of Section 40 of the said Act, and also not a single person could be nominated by the Vice-Chancellor under clause (b) of sub-section (2) of Section 40 of the said Act due to non availability of qualified persons;

And,

Whereas, on some Board of Studies, the members elected or nominated are not qualified to be elected as Chairperson of the Board of Studies under sub clause (i) of the clause (d) of sub section (2) of Section 40 of the said Act;



And ,

Whereas, in view of the larger interest of the students, for maintaining the standard of higher education and to carry out the functions and matters issues related to the Board of Studies of the university, it is necessary to constitute Ad-hoc Board of Studies and to appoint Ad-hoc Chairpersons of Board of Studies in the respective situations, for this purpose, it requires to frame Statute under Section 72 of said Act;

And,

Whereas, the framing of Statutes under the provision of Section 72 of the said Act, requires the approval of various authorities;

And,

Whereas, in absence of the said Statutes and having regard to the urgent need of the matter to constitute the Ad-hoc Board of Studies and to appoint Ad-hoc Chairpersons of the Board of Studies, it is necessary to issue the direction.

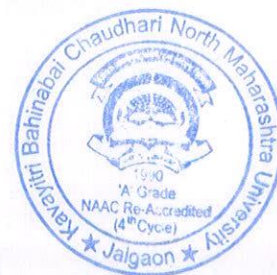
Now, therefore, I, Prof.Vijay Laxminarayan Maheshwari, Vice-Chancellor, Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon being satisfied about the exigency to issue the direction, in exercise of powers vested in me under sub-section 8 of Section 12 of the said Act, do hereby issue the following direction to regulate the matter in relation to constitution of Ad-hoc Board of Studies and to appoint Ad-hoc Chairpersons of Board of Studies of this University.

1.When there is less than three valid nominations received for election under clause (c) of sub-section (2) of Section 40 of the said Act, and also not a single duly qualified person could be nominated by the Vice-Chancellor under clause (b) of sub-section (2) of Section 40 of the said Act, the Vice-Chancellor shall constitute Ad-hoc Board of Studies consisting of not more than 10 members, of whom, three shall be experts from outside the University. The Vice-Chancellor shall appoint one of the members as Chairperson,

However, the tenure of Ad-hoc Board of Studies shall not be more than two years or till the constitution of regular Board of Studies, whichever is earlier. The Ad-hoc Board shall have same powers and duties as that of regular Board of Studies, however, members of Ad-hoc Board shall not have right to vote and to contest the election of any authority.

2.When the members elected or nominated on Board of Studies are not qualified to be elected as Chairperson of the Board of Studies under sub clause (i) of clause (d) of sub section (2) of Section 40 of the said Act, the Vice-Chancellor shall nominate one of the members of the Board of Studies as Ad-hoc Chairperson of the Board of Studies. In such case, Board of Studies will be regular with a term of 5 years in the light of Section 62 of the said Act, however, the tenure of Ad-hoc Chairperson shall not be more than two years or till the appointment of regular Chairperson of Board of Studies, whichever is earlier. The Ad-hoc Chairperson of Board of Studies shall have same powers and duties as that of regular Chairperson of the Board of Studies; however, he shall not have right to vote and to contest the election of any authority.


3.The candidates declared duly elected on Board of Studies as per Section 40 (2)( c), but their strength is less than three, in such case, concerned Board of Studies will be Ad-hoc.





This Direction may be called here in after as Direction for Governing the Constitution of Ad-hoc Board of Studies and appointments of Ad-hoc Chairpersons of the Board of Studies of Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon.

The Direction shall come into force from the date of its issuance and shall remain in force until the relevant Statutes have been made in accordance with the provisions of the said Act or for a period of six months; whichever is earlier
