CIRCULAR NO - 48/2023

Sub: Circular regarding allotment of Internal Research Guide for Research Work for M. Pharmacy Students.
Ref: Meeting of Board of Studies in Pharmaceutics, Pharmaceutical Chemistry, Pharmacognosy, Pharmacology and B Tech (Cosmetics) held on 20/08/2018..

In connection with the above subject matter, you are, hereby, informed as under :

1. As per the subject number 08 & resolution number 08 passed in the meeting of Board of Studies in Pharmaceutics, Pharmaceutical Chemistry, Pharmacognosy, Pharmacology and B Tech (Cosmetics) held on 20/08/2018, the allotment of internal research guide for research work to M. Pharmacy students in semester III and IV should be done as per the subject equivalence to the specializations prescribed in the Master of Pharmacy Course regulations 2014 by the Pharmacy Council of India New Delhi.
2. If the faculty members engaged in post graduate teaching in the affiliated colleges with KBCNMU, Jalgaon were awarded with the approval as the "Post Graduate Teacher in the subject Pharmacy", then, for such cases, the post graduate teacher approval should be considered in the subject as per the specialization (Subject) at master of pharmacy degree.
3. If the faculty members engaged in post graduate teaching in the affiliated colleges with KBCNMU, Jalgaon were awarded with the approval as the Post Graduate Teacher in the subject other than their specialization (Subject) at master of pharmacy degree or in any equivalent subject as per the applicable regulations prior to the adopted regulations of the Pharmacy Council of India before the academic year 2017-18, then, for such cases, the post graduate teacher approval should be considered in the subject as per the specialization (Subject) at master of pharmacy degree.
4. If in the affiliated colleges, the post graduate teachers are not available for Master of Pharmacy course, then, for the end semester practical examinations in semester I,II & III (CA), the internal examiner will be appointed by the university from other affiliated colleges.
5. For semester III & IV, the affiliated colleges should allot post graduate teacher available in the college as an Internal research guide as per the subject equivalence prescribed in the Master of Pharmacy course regulations 2014 laid down by the Pharmacy Council of India, New Delhi. No internal examiners are allowed from other affiliated colleges, as there is no provision in the Master of Pharmacy syllabus framed by the PCI, New Delhi, which is adopted from the academic year 2017-18.
6. As per the Master of Pharmacy course regulations 2014, cadre ratio for M. Pharmacy per specialization is 1:3 but as per the recommendations by the constituted committee regarding May 2023 Examination of M. Pharm Semester IV Dissertation by the KBCNMU Jalgaon, the cadre ratio for submission of Thesis/Project Report/Dissertation primarily will be fixed at 1:5 from academic year 2023-24, subject to approval by the BOEE & Academic Council of the KBCNMU, Jalgaon.
7. Colleges must enclose an attested copy/s of thumb impression reports of student/s' attendance while submitting examination form/s of concerned student/s.
8. One copy of M.Pharm. dissertation/thesis be submitted to the University.

Please adhere to the above instructions in letter and spirit and cooperate with the University.
