

1. विद्यापीठाच्या प्रशाळा व विभागातील तसेच संलग्नित महाविद्यालये व परिसंस्थेतील विविध शाखेअंतर्गत विषयांकरीता एम.फिल. व पीएच.डी. साठी संशोधक मार्गदर्शक व पदव्युत्तर शिक्षक मान्यता म्हणून मान्यता देण्यासाठी शैक्षणिक पात्रता.

1.1 Assistant Professor of the University / affiliated Colleges / Institutions:

1. Full-time approved and regular Assistant Professor of KBC NMU, Jalgaon.
2. Ph.D. degree in the relevant subject.
3. At least two (2) research publications in the concerned subject, other than Ph.D. work published in the journals indexed in peer reviewed referred or UGC CARE list.

1.2 Associate Professor of the University / affiliated Colleges / Institutions:

- 1) Full-time approved and regular Associate Professor of KBC NMU, Jalgaon.
- 2) Ph.D. degree in the relevant subject.
- 3) At least two (2) research publications in the concerned subject, other than Ph.D., work published in UGC CARE list.

1.3 Professor of the University / Affiliated Colleges / Institutions:

- 1) Full-time approved Professor of KBC NMU, Jalgaon.
- 2) Ph.D. degree in the relevant subject.
- 3) At least five (5) research publications in the concerned subject published in the journals indexed in UGC CARE list.

- 1.4 Provided that in areas / disciplines where, there is no or only a limited number of peer reviewed referred journals indexed in UGC CARE list, the University may relax the above condition for recognition of a person as a research Guide with reason recorded in writing.

1.5 Allocation of scholars to Research Guide :

- a) Research Guide / Co-guide who is a Professor, at any given point of time, cannot guide more than three (3) M.Phil. and eight (8) Ph.D. Students.
- b) Associate Professor as a Research Guide can guide upto a maximum of two (2) M.Phil. and six (6) Ph.D. Scholars and
- c) Assistant Professor as a Research Guide can guide upto a maximum of one (1) M.Phil. and four (4) Ph.D. Scholars.

1.6 Provision of Research Co-Guide.

In case of topics which are inter-disciplinary in nature, the experience in the subject has to be supplemented from outside. Co-Supervisor from outside the Department / Faculty / College / Institution on such terms and conditions as may be specified / agreed upon by the concerned Institutions / Colleges.

Co-guide should not extend supervision to more than two (2) M.Phil./Ph.D. scholars.

1.7 Resolution of Foreign / NRI scholar.

Guide should not extend supervision to more than two (2) Foreign/NRI scholars (within intake).

1.8 Resolution of M.Phil. / Ph.D. women scholar.

In case of relocation of M.Phil./Ph.D. women scholars due to marriage or otherwise, the research data shall be allowed to be transferred to the University to which the scholar intends to relocate, provided all the other conditions in these regulations are followed in letter and spirit and the research work does not pertain in the project secured by parent institution / supervisor from any funding agency. The scholar will, however, give due credit to the parent guide and the institution for the part of research already done.

2. संबंधीत महाविद्यालयांमधील मानवविज्ञान विद्याशाखा, विज्ञान व तंत्रज्ञान विद्याशाखा (अभियांत्रिकी व औषधनिर्माणशास्त्र वगळता), वाणिज्य व व्यवस्थापन विद्याशाखा व आंतरविद्याशाखीय अभ्यास विद्याशाखा अंतर्गत विषयांसाठी पव्युत्तर शिक्षक म्हणून मान्यता देण्यासाठी शिक्षकांकरीता शैक्षणिक पात्रता.

2.1 Recognition as P.G. Teacher (by papers) All faculties (Other than Engineering & Pharmacy)

2.1.1 The teacher applying for PG recognition should belong to a college where, P.G. Course in the concerned subject is offered.

2.1.2 Approved full-time teacher having Ph.D. degree in the concerned subject

OR

Five years research experience of teaching at degree level in senior College OR M.Phil. with three years teaching experience in senior college.

2.2 Recognition as P.G. Teacher (by papers) (M.Pharm. / M.E. / M.Tech).

2.2.1 The teacher applying for PG recognition should belong to a college where, P.G. course in the concerned subject is offered.

2.2.2 Approved full-time teacher with Master's degree in the concerned subject.

2.2.3 Five years research experience **OR** Five years professional experience (teaching/ Industrial) of which three years must be in responsible position.

Rules for Post-Graduate Teacher / M. Phil / Ph.D. Research Guide

1) General Rules:

- a) Applicant shall submit his/her application form within the time frame notified by the University.
- b) A hard copy of the application form shall be submitted to the Research Section of the University along with the necessary documents duly signed by the Principal / Director of the Affiliated College / Recognized Institution / Director of the University School and Head of University Department.
- c) Applicant shall be a full-time regular approved teacher working in the Affiliated College / Recognized Institution or a full-time regular Research Scientist in Recognized Research Institute of **Kavayitri Bahinabai Chaudhari North Maharashtra University** or a full time approved regular teacher working in the University School / Department / Center.

2) Rules for Recognition as Post-Graduate Teacher:

- a) Five years teaching experience at degree level as an approved teacher / Three years teaching experience with Ph.D.
- b) If a teacher is directly appointed as a Post-graduate teacher and has received permanent approval from the University, he need not apply for recognition as a Post-Graduate teacher.
- c) A teacher once recognized as a Post-graduate teacher need not to apply for renewal! / Continuation of recognition even though he / she changes the Affiliated College / Recognized Institution from where he / she had applied for recognition as a Post Graduate teacher. However, he / she has to apply for the change of address **and If that research center is not recognized by university then it is responsibility of teacher either take research lab / research center recognition or produce undertaking of nearest recognized research lab / research center.**
- d) A Teacher recognized as a Post Graduate Teacher from other than **Kavayitri Bahinabai Chaudhari North Maharashtra University** within Maharashtra needs to apply online for address change if he / she is transferred to **Kavayitri Bahinabai Chaudhari North Maharashtra University** jurisdiction.

3) University Grants Commission, (Minimum Standards and Procedure for Award of M.Phil / Ph.D. Degree), Regulation 2016 and amendments made there In from time to time shall apply to M.Phil / Ph.D. Research Guideship.

4) Rules for Recognition as M.Phil Research Guide (By Paper / By Research)

- a) M.Phil. Research Guide by Paper:
 - (i) Applicant shall be a Ph.D. degree holder in the subject to which he wishes to apply for recognition.
 - (ii) Applicant shall be a regular Professor of the University/Institution/College with at least five research publications in refereed journals or a regular Associate / Assistant Professor of the University/Institution/College with at least two research publications in refereed journals, after Ph.D.
 - (iii) In area / disciplines where there is no or only a limited number of refereed journals, the University Authority may relax the condition mentioned in above point No.4 (a) (ii) with reason to be recorded in writing.
- b) M.Phil. Research Guide by Research:
 - (i) Applicant shall be a Ph.D. degree holder in the subject to which he wishes to apply for recognition.

- (ii) Applicant shall be a regular Professor of the University / Institution / College with at least five research publications as corresponding author in refereed journals or a regular Associate / Assistant Professor of the University / Institution / College with atleast two research publications as corresponding author in refereed journals, after Ph.D.

5) Rules for Recognition as Ph.D. Research Guide for all faculties:

- a) Applicant shall be a regular Professor of the University / Institution / College with at least five research publications in refereed journals after Ph.D. or a regular Associate / Assistant Professor of the University / Institution / College with at least two research publications in refereed journals after Ph.D.
- b) In area / disciplines where there is no or only a limited number of refereed journals, the University Authority may relax the condition mentioned in above point No.5 (a) with reason to be recorded in writing.

6) Conditions Governing the M. Phil. / Ph.D. Research Guideship:

- (i) If an applicant is awarded recognition as a Research Guide, the recognition for the guideship will be continued upto attaining the age of 60 years, or till he is a regular teacher in the University School / Department / Affiliated College / Recognized Institution / Recognized Research Institute from which he had made an application for the Guideship, whichever is earlier. however, a recognized Guide can register Ph.D. Students till age of 57 years. He / she will remain as Research Guide till all candidates registered under him / her submit their Thesis or continue guideship till age of 65 years. whichever is earlier. At the age of 65 years the Research Guide shall have to transfer remaining students if any to co-guide.
- (ii) M.Phil. Recognized Guides shall be deemed to be recognized as Post Graduate Teacher.
- (iii) Ph.D. Recognized Guides shall be deemed to be recognized as M.Phil. (By Paper / By Research) & Post Graduate Teacher.
- (iv) M. Phil. Guideship is co-terminus with the Ph. D. Guideship.
- (v) Applicant shall not be eligible for making fresh application for recognition as a Post Graduate Teacher / M.Phil. guide (by papers / research) / Ph. D guide, if he / she has attained the age of 60 years.
- (vi) It is essential to arrange for a co-guide who shall be approved Research Guide of **Kavayitri Bahinabai Chaudhari North Maharashtra University** to guide already registered research students in case of those M.Phil. / Ph.D. Research Guides whose remaining service as a 'Regular Teacher' is less than one year.
- (vii) No fresh M.Phil. /Ph.D. 'Research Students' shall be registered with M.Phil. / Ph.D. Research Guides whose remaining service as a 'Regular Teacher' is less than one year.
- (viii) A Research Supervisor/Co-supervisor who is a Professor, at any given point of time, cannot guide more than three (3) M.Phil. and eight (8) Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of two (2) M. Phil. and six (6) Ph.D. scholars and an Assistant Professor as a Research Supervisor can guide up to a maximum of one (1) M.Phil. and four (4) Ph.D. scholars.
- (ix) An applicant for M.Phil./ Ph.D. Research Guideship can make applications for maximum two subjects only (two separate applications).
