Norms regarding recognition as Research Institution/ Post Graduate Research Centres in affiliated College/Post Graduate Research Centres in Recognised Institutions.

[Reference: 1) University Grants Commission (Minimum Standards and procedure for award of M. Phil/Ph.D. degree) Regulation 2016 publish in the Gazette of India (No. 278 Dt. 05-07-2016).

Preamble :

The National Education Policy (NEP) 2020 envisages the promotion of quality research within the Higher Education system. Research and innovation are important aspects to enhance quality education by the Higher Education Institutions (HEIs). Societal challenges of our country can only be addressed by having a strong and vibrant higher education ecosystem with an emphasis on research, innovation, and technology development. The integration of Research, Innovation and Technology Development is the foundation of Atma-Nirbhar Bharat (Self-reliant India). The establishment of Research and Development Cell (RDC) in the colleges/Institutes will enable attainment of targets of Atma-Nirbhar Bharat and is expected to play a pivotal role in catalysing multidisciplinary/transdisciplinary and translational research culture mandated in NEP 2020.

Developments in research is growing fast in University region since last 30 years in Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. P.G. Students enrolment has increased and the number of students qualifying PET examination conducted by the university has also increased, leading to increase in number of researchers every year. As per UGC notification 2009 – PET exam, Pre Ph.D. Course work, Guide Course work, submission of research papers, internal marks, assessment of researcher by guide is the mandatory part of research centre.

To promote quality research in Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon It is the need of time to establish more research Centres / laboratories in Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon

Objectives of Research Centre/Laboratory:

1. To create awareness of research and development amongst the P.G. students and faculty members.
2. To provide research facilities and guidance to the researchers at recognised research Centres /laboratories.
3. To provide service to society, industry, business regarding research and innovations.
4. To conduct seminars, conference and Ph.D. course work of Research Methodology and subject course regularly.
5. To create an organizational structure with role-based functions of RDC, formulate Research Policy for the HEIs, identify thrust areas of research, and form related cluster groups/ frontline teams/consortia of researchers.
6. To create enabling provisions in Research Policies for recruitment of research personnel, procurement of equipment, and financial management with adequate autonomy to the Principal Investigator(s) and disseminate research outcomes to stakeholders and the public at large.

7. To establish a special purpose vehicle to promote researchers and innovators, identify potential collaborators from industry, research organizations, academic institutions & other stakeholders for cooperation and synergistic partnerships.
8. To act as a liaison between researchers & relevant research funding agencies, extend guidance in preparation & submission of project proposals and post-sanctioning of the grants to oversee adherence to timelines.
9. To have better coordination among other cells/Centres dealing with University-Industry Inter Linkage, Incubation, Innovation and Entrepreneurship Development and Intellectual Property Rights (IPR).
10. To develop an Institutional Research Information System for sharing the status of ongoing/ completed research projects/Programmes, expertise & resources, etc., making effective use of Information & Communication Technology (ICT) for preparing the database of in-house experts to provide industrial consultancy and services.
11. To engage & utilize the services of superannuated active faculty/scientists in research capacity building of talented young minds and promote mobility of researchers across institutions and R&D Labs.
12. To serve as nodal centre for ideation and conceptualization of research topics/themes by organizing workshops and training programs and ensuring the integrity and ethical practices in research activities including clearance of bioethical committee wherever required.

Functions of Research Centres:

The UGC launched an initiative to establish a RDC in HEIs with the mandate for promoting quality research that contributes meaningfully towards the goal of a self-reliant India ("Atma-Nirbhar Bharat"), aligned with the provisions of NEP-2020. The RDC would help creating a research ecosystem for reliable, impactful, and sustained research output. The essential elements of such an ecosystem, viz., generation of knowledge and facilitation of research, innovation and technology development for industrial & societal benefits, are addressed by human resource (researcher & faculty), intellectual capital (knowledge & skills), governance (regulation & policies) and financial resources (funding & grants).

Norms for recognition for Research centre:

1. Those colleges having Postgraduate in a relevant subject are only eligible to apply for the recognition of Research Centre. *as per mission in MPVA 116*
2. The college shall have at least two regular, approved P.G. teachers for P.G. teaching, whose qualification and experience shall be as described by the U.G.C. from time to time in concern subject.
3. The college shall have at least One recognized research guide in the concerned subject.

4. National /State level research Organisations and private research institutes of National/ International repute shall be eligible to apply for a research recognition as approved Research Centres in the concerned subjects of their expertise.
5. The college shall have adequate space and infrastructure for guide and students for undertaking research programme leading to M. Phil /Ph.D., in the relevant subject.
6. The college shall have uninterrupted water, electricity supply and uninterrupted internet connectivity to research guide and students and facility to work in extended working hours.
7. The college shall have adequate reference books and journals in the library and sufficient space for research students and guide.
8. The students of recognized research Centres may access the special required facilities, equipment's from neighbouring research recognized colleges/Institutes/R & D laboratories.
9. Research centre will be renewed if
 - a) Faculty shall publish at least two research papers in U.G.C. approved/UGC'S CARE List/Peer reviewed/referred Journal list during last three years.
 - b) Faculty shall present research papers in National/International Conferences list during those three years.
 - c) Centre shall subscribe at least five research journals.
 - d) College shall continue PG classes and maintain the required number of PG teachers and Ph.D. supervisors.

Fees :

1. Application & Processing fee (non-refundable) for research centre – Rs. 5000/- per subject.
2. Research Centre recognition/Renewal fee for Science & Technology subjects – Rs. 5000/- per year/per subject and Rs. 3000/- per year/per subject for other than Science & Technology subjects.
