**MINIMUM QUALIFICATION FOR APPOINTMENT OF TEACHERS IN COLLEGES, AS PER UGC REGULATIONS – 2010.**

**ASSISTANT PROFESSOR**

**A)Foundation Course**

- 1) Master's Degree in Science /Humanities /Arts with 50% marks (or an equivalent grade in a point scale wherever grading system is followed)
- 2) M. Ed with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and
- 3) Any other stipulation prescribed by the UGC/any such affiliating body/state government, from time to time for the position of principal and lecturers, shall be mandatory ,

**OR**

- 1) M.A. in Education with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) ) and
- 2) B. Ed with at least 55%( marks or an equivalent grade in a point scale wherever grading system is followed) )
- 3) Any other stipulation prescribed by the UGC/any such affiliating body/state government, from time to time for the position of principal and lecturers, shall be mandatory.

**B] Methodology Course**

- 1) A Master's Degree in subject with 50 % marks (or an equivalent grade in a point scale wherever grading system is followed)

- 2) M. Ed Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed ) and
- 3) Any other stipulation prescribed by the UGC/ any such affiliating body/ State Government from time to time for the position of principal and lecturers, shall be mandatory.

Provided that at least one lecturer should have specialization in ICT and another in the special Education.

### **LIBRARIAN**

- i) Master's degree in Library Science / Information Science / Documentation Science or an equivalent professional degree with at least 55% of the marks or its equivalent grade of 55 % marks where grading system is practiced and a consistently good academic record with knowledge on computerization of library.
- ii) Qualifying in the National Eligibility Test [NET] or other accredited test like SLET/ SET in Library science conducted for the purpose by the UGC or any other agency approved by the UGC.
- iii) Holders of Ph. D degree as on the date of Notification of Regulations, along with those candidates who are awarded a Ph. D degree through a process of admission registration, course work and external evaluation as laid down in the UGC [Minimum Standards and procedure for award of Ph. D Degree], Regulations 2009 and so adopted by the university shall be exempted from NET/SLET/SET.
- iv) A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/ Differently - abled (physically and visually differently - abled) /Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5 % to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.

### **Social Reservations.**

- 1) As per the Government Resolutions No. CBC-10/2003/P.K/MVK, Dated 28 th January, 2004 SC/VJ-NT/OBC Candidates shall submit their Validity Certificates within 03 months from the date of joining [if validity is not available at the time of interview]
- 2) As Per the Government Resolution NO. STC-1099/PK-14/C-10 Dated 16th August 2000 & STC/1420/PK-43/C-10, Dated 27th January, 2003 candidates belonging to ST Category is mandatory to submit Caste Validity Certificate at the time of interview.
- 3) As Per the Government Resolutions No. CBC - 1097/PK-2/97/16 B, Dated 29<sup>th</sup> March 1997 A/B/C/D Points in VJNT Category are inter changeable.
- 4) As per the Government Resolutions No. CBC-10/2006/PK-15/MVK-5, Dated 05th June 2006 candidates belonging to VJ/NT , OBC & SBC will have to submit Non Creamy Layer Certificate at the time of interview.

### **Parallel Reservation.**

As per the government Resolutions No. SRV-1097/PK-31/98/16-1, Dated 15 th March 1999 3% Reservation for Physically Handicapped and 30 % Reservation for Women shall be observed.
