MINIMUM, QUALIFICATIONS FOR APPOINTMENT OF TEACHER IN COLLEGE AS PER UGC REGULATIONS

### A.QUALIFICATION FOR B.Ed. COURSE

#### (i) **PRINCIPAL/HEAD** (in Multi-Faculty institution)

- a. Academic and Professional Qualification Will be as prescribed for the post of lecturer.
- b. Ph.D. in Education; and
- c. Ten years teaching experience out of which at least five years teaching experience in a Secondary Teacher Educational Institution.
- d. A Relaxation of 5 % May be provided from 55 % to 50 % of the marks to the Ph.D. Degree holders who have passed their Master's degree prior to 19<sup>th</sup> September, 1991.
- e. As per rule of Govt. of Maharashtra / U.G.C Regulations the term of College Principal shall be five years with eligibility for reappointment for one more terms only after a similar selection committee.

*Provided* That, in the event of non-availability of eligible and suitable candidates for appointment as principal/ head as per above eligibility criteria, it would be permissible to appoint retired professor/ Head in education on contract basis for a period not exceeding one year at a time, till such time the candidates compete sixty five years of age.

## (ii) ASSISTANT PROFESSOR:

#### a. Foundation Courses

- 1. A Master's degree in Science/ Humanities/Arts with 50% marks (or an equivalent grade in a point scale wherever grading system is followed);
- 2. M.ED. with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed); and
- 3. Any other stipulation prescribed by the UGC/ and such affiliating body/ state Government, from time to time the positions of principal and lectures, shall be mandatory;

OR

- 1. M.A. in Education with 55% marks (or an equivalent grade in a point scale wherever grading system is followed);
- 2. B.ED. with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and
- 3. Any other stipulation prescribed by the UGC/ any such affiliating body/ state Government, from time to time the positions of principal and lectures, shall be mandatory;

#### b. Methodology Courses B.Ed.

- 1.A Master's Degree in Subject With 50%, marks (or an equivalent grade in a point scale wherever grading system is followed);
- 2. M.Ed. with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and
- 3. Any other stipulation prescribed by the UGC/ any such affiliating body/ State Government, from time to time the positions of principal and lecturers, shall be mandatory.
- *Provided* that at least one lecturer should have specializations in ICT and another in the special education.

#### LIBRARIAN

- I. Master's degree in library Science/information Science/ Documentation Science or an equivalent professional degree with at least 55% of the marks or its equivalents grade 55% marks where grading system is practiced and a consistently good academic record with Knowledge on computerization of library.
- II. Qualifying in the National Eligibility Test (NET) or other accredited test like SLET/SET in Library Science conducted for the purpose by the UGC or any other agency approved by the UGC.
- III. Holders of Ph.D. Degree as on the date of Notification of these regulation, along with those candidates who are awarded a Ph.D. degree through a process of admission, registration, course work and external evaluation as laid down in the UGC (Minimum Standards and Procedure for award Ph.D. Degree), Regulation, 2009 and so adopted by the University shall be exempted from NET/SLET/SET.
- IV. A relaxation of 5% may be provided at the graduate and master's level for the SC/ ST Differently-abled categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching to teaching position, Rounding off of marks to make it to 55% or 50% as the case may be through grace mark procedure etc., by universities is not permissible for claiming relaxation.

#### SOCIAL RESERVATION

- As per Government Resolution No. CBC-10/2003/P.K./MVK, Dated 28<sup>th</sup> January, 2004, SC/VJ-NT/ OBC Candidates shall submit their Validity Certificate within 03 months from the date of joining (if validity is not available at the time of interview)
- As per the Government Resolution NO. STC-1099/PK-14/C-10, Dated 16<sup>th</sup> August,2000 & STC/ 14200/PK-43/C-10, dated 27<sup>th</sup> January, 2003 candidates belonging to ST Category is mandatory to submit Caste Validity Certificate at the time of interview.
- iii. As per the Government Resolution No. STC-1099/PK-2/97/16 B, Dated 29<sup>th</sup> March, 1997, A/B/C/D points in VJ/NT Category are interchangeable.

iv. As per the government Resolution No. CBC-10/2006/PK-15/MVK-5 Dated 05<sup>th</sup> June,2006 Candidates belonging to VJ/NT, OBC & SBC will have to submit Non-Creamy Layer Certificate at the time of interview.
